

BIOGRAPHIES





Joaquín ALMUNIA is visiting Professor at Sciences-Po's Paris School of International Affairs and Chairman of the Board of the Centre for European Policy Studies (CEPS). He is also the Honorary President of the Barcelona School of Economics. From April 2004 to October 2014 he has been a member of the European Commission, in charge of Economic and Monetary Affairs and, since February 2010, as Vice-President of the Commission, he was in charge of Competition Policy. He was member of the Spanish government, first as minister of Labour and Social Security (1982-1986) and later minister for Public Administration (1986-1991). Has been a member of the Spanish Parliament (1979-2004) and the leader of the Spanish Socialist Party, PSOE (1997-2000). He has degrees in Economics (1971) and Law (1972) from the University of Deusto (Bilbao, Spain).



Javier ÁLVAREZ-GÁLVEZ holds a PhD from the Complutense University of Madrid. He currently works as Senior Research Fellow (Ramon & Cajal) in the Department of Biomedicine, Biotechnology and Public Health at the University of Cadiz, where he teaches biostatistics, quantitative methods, multivariate data analysis and public health. His main research interests are related to social and health data science, research methodology, social and health systems, social determinants of health, social inequalities in (mental) health and suicide, health behaviours and health sociology. He currently leads the DEMMOCAD project focused on the study of social inequalities in multimorbidity and the DCODES project which is centred on the study of health misinformation in social media.



László ANDOR is Secretary General of the FEPS. An economist and former EU Commissioner for Employment, Social Affairs and Inclusion (2010-2014), Andor has been Head of the Department of Economic Policy at Corvinus University (Budapest), Senior Fellow at Hertie School of Governance (Berlin) and a visiting professor at ULB (Brussels) and Sciences Po (Paris). He was editor of the journal *Eszmélet* and a regular columnist for *Figyelo* and *Népszava*. He has authored, edited or co-edited a dozen books in Hungary. Andor has also taught at Rutgers University as Visiting Fulbright Professor, worked as an advisor for the World Bank on SAPRI, the Budget Committee of the Hungarian Parliament (1998-1999) and the prime minister's office (2002-2005), and was also a member of the Board of Directors of the EBRD. He holds a degree in Economic Sciences from Karl Marx (now Corvinus) University, an MA in Development Economics from the University of Manchester and a PhD from the Hungarian Academy of Sciences. He was awarded Doctor Honoris Causa at Sofia University of National and World Economy and the Legion of Honour by the President of France (2014).



Helen BARNARD is the Director of Research and Policy at Pro Bono Economics and Associate Director of the Joseph Rowntree Foundation (JRF). Helen is a leading UK expert on poverty, inequality and social policy. Her extensive body of written work and regular media contributions have covered poverty, destitution, labour markets, housing and social security.



Ana CHUPESKA holds a Master of Science in International Relations and a PhD in Political Science. She is Associate Professor at the Political Science Department of the ("Iustinianus Primus" Law Faculty, University Ss. Cyrilus and Methodius, North Macedonia, where she teaches several subjects and where she is the head of the Political Science Master Collegium. Ana Chupeska is also a member of the FEPS Scientific Council.



Maciej GDULA is a member of the Sejm of the Republic of Poland for the social democratic New Left party. He is a sociologist and adjunct professor at the Faculty of Sociology of the University of Warsaw. Maciej is specialised in social and class theory.



Hedwig GIUSTO is Senior Research Fellow at the Foundation for European Progressive Studies (FEPS) working predominantly on migration and the Balkans. Since September 2020 she is editor-in-chief of the Progressive Post, the magazine run by FEPS. She holds a PhD in History of International Relations from the University of Florence and an MSc in History of International Relations from the London School of Economics.



Katarína KLINGOVÁ is a Senior Research Fellow at the GLOBSEC Policy Institute, a think tank based in Bratislava. As member of GLOBSEC's Democracy & Resilience Program she has been analysing disinformation and influence operations in central Europe since 2016. She has authored or co-authored numerous analyses on the impact of information operations and social media on a democratic society, building societal resilience against hybrid threats and strategic communication. In her previous capacities, she worked for Transparency International Slovakia and the European Commission.



Roman KUCHAR is Professor of Sociology at the Faculty of Arts, University of Ljubljana. He is the author of several books including (with J. Takács) *Beyond the Pink Curtain: Everyday life of LGBT people in Eastern Europe* (Peace Institute, 2007) and (with D. Paternotte) *Anti-gender Campaigns in Europe: Mobilizing against Equality* (Rowman & Littlefield, 2017). He is an associate editor at *Social Politics* (Oxford University Press), the former dean of the Faculty of Arts (2017-2021) and the president of the Slovenian Sociological Association.



Pascal LAMY (pascallamy.eu) is the President of the Paris Peace Forum, he coordinates the Jacques Delors Institutes (Paris, Berlin, Brussels) and chairs the board of the EU “Starfish” (ocean) mission. He previously served two terms as Director-General of the World Trade Organization (2005-2013), as European trade Commissioner, and as chief of staff of the President of the European Commission Jacques Delors (1985-1994). His latest book is *Strange New World* (Odile Jacob 2020).



Grzegorz PIETRUCZUK is a local government official, a political scientist and a publicist. He graduated in Political Science at the Faculty of Journalism and Political Science, the University of Warsaw. Between 1998 and 2002, he was a councilor of the Warsaw-Bielany District. In 2004-2005, he was the Head of the political cabinet of the Minister of the Interior Affairs and Administration. From 2006 to 2018, he was Deputy Mayor of the Bielany District of the capital city Warsaw (three terms of office). He has also been councilor of the Sejmik of the

Mazovian Voivodship (2010-2014). Since 2018 he is mayor of the Warsaw Bielany District. Finally he is the Chairman of the “Together for Bielany” Association.



Maria João RODRIGUES, former Portuguese Minister of Employment in Portugal of Prime Minister Antonio Guterres, is President of FEPS. She is a European politician with a long track record in different European institutions: EU Presidencies, Council, European Council, European Commission and, more recently, the European Parliament where she was Vice-President of the S&D Group, in charge of the general coordination and interface with the other EU institutions. She played a relevant role in several important European initiatives including the

Lisbon Treaty, the Lisbon and the Europe 2020 strategy, the Eurozone reform, the roadmap for EU’s future and, more recently, the European Pillar of Social Rights. In her academic life, Rodrigues was professor of European economic policies in the European Studies Institute -

Université Libre de Bruxelles and in the Lisbon University Institute. She was also the chair of the European Commission Advisory Board for socio-economic sciences. She is the author of more than one hundred publications.



Pedro SÁNCHEZ has been President of the Government of Spain since June 2018. He holds a Doctorate in Economics and is General Secretary of the Spanish Socialist Workers' Party (PSOE), which he joined in 1993. He was also Leader of the Opposition and candidate to the Presidency of the Government between 2014 and 2016. Previously, he was a Member of the Lower House of Parliament for the constituency of Madrid and a city councillor for Madrid.



Ania SKRZYPEK (Skrzypek-Claassens) is Director for Research and Training at the Foundations for European Progressive Studies (FEPS). She holds a PhD cum laude in Political Sciences from the University of Warsaw, a degree which she obtained for her thesis "Cooperation of the socialist and social democratic parties in uniting Europe. From Liaison Bureau to PES. 1957-2007" (published in 2010). Before joining FEPS in 2009, Skrzypek worked as young researcher at the Faculty of Journalism and Political Sciences at the University of Warsaw (2003-2009) and also served as Secretary General of Young European Socialists for twice consecutive terms (ECOSY, 2005-2009). She is an author of over 80 published papers and articles, available in English, German, French and Polish.



Eric SUNDSTRÖM works as a Research Fellow and Communication strategist at LO, the Swedish trade union confederation. He is also a columnist and lecturer, both in Sweden and internationally. Sundström previously served as Political Advisor to the Swedish Minister for Foreign Affairs Margot Wallström, and as speechwriter to Prime Minister Stefan Löfven. His professional background is found in the intersection where social democracy and international politics meet journalism and communication. He has been editor-in-chief of progressive newspapers and magazines produced both in Stockholm and Berlin; and worked with think tanks in Washington D.C. and Brussels. Eric pursued his studies at universities in Stockholm, Glasgow and Montpellier. He holds an MA from Johns Hopkins University SAIS (Bologna/Washington DC). He has served as president of Social Democratic Students of Sweden and as a bureau member of Young European Socialists.

E Hun focuses on developing and delivering policy, and on empowering local communities and the wider public in Malaysia. She regularly works with key stakeholders including parliamentarians, ministries, government agencies and civil society

organisations to shape public policy discourse, and she frequently participates in media interviews, commentaries, focus groups, working committees and roundtable discussions.



Jack THOMPSON is Lecturer in American Studies at the University of Amsterdam. Previously, he worked at think tanks in Switzerland and the Netherlands and taught at University College Dublin. His research focuses on the influence of political culture on US grand strategy, efforts to rebalance the transatlantic relationship, the history of US conservatism, and the radicalisation of the US right. He is the author or co-editor of numerous books, articles and policy reports, including *Progressivism in America: Past, Present, and Future* (Oxford University

Press). His 2019 book, *Great Power Rising: Theodore Roosevelt and the Politics of US Foreign Policy* (Oxford University Press), won the 2020 Theodore Roosevelt Association Book Prize. He holds a PhD in history from the University of Cambridge and a master's degree in international relations and international economics from the Johns Hopkins University School of Advanced International Studies.



Loukas TSOUKALIS is affiliate professor at the Paris School of International Affairs at Sciences Po, Emeritus Professor of the University of Athens, and president of the Hellenic Foundation for European and Foreign Policy (ELIAMEP). He is the author of many books published by Oxford University Press and translated into several language. His new book *Europe's Coming of Age* was published in 2022.
